**FROM PAST TO PRESENT  
Changing Climates, Ecosystems and Environments of Arid Southern Africa  
A Tribute to Louis Scott**

**7-11 July 2014**

“Palaeoecology of Africa” was founded in 1966 by Eduard van Zinderen Bakker and started under the title “Palaeoecology of Africa and the surrounding islands and Antarctica”. While the original focus of the series was mainly palynological, the interdisciplinary character of palaeoclimatic and palaeoenvironmental research became obvious during the years and therefore the scope of “PoA” turned into a broader perspective – including biogeography, archaeology, geology, geomorphology, pedology and other related fields which have a focus on the study of the past and present African environments. Since then “Palaeoecology of Africa” has become an independent international medium for palaeoenvironmental research in Africa.

In 2005 Jürgen Runge from Goethe University, Frankfurt, Germany, took over the editorship of the series. Assisted by Routledge and Taylor & Francis Publishers PoA was restarted in 2007 with its 28<sup>th</sup> volume and new conception and modern layout (also availability as an e-book). The editorial board of the series was restructured allowing to profit from the scientific input and expertise of other dynamic colleagues interested in the topic.

The series main title was changed to “Palaeoecology of Africa - International Yearbook of Landscape Evolution and Palaeoenvironments”. The goals of “Palaeoecology of Africa” are to provide insights and broad overviews of landscape evolution, palaeoenvironments and assessments of the general ecological, environmental and landscape features of various ecosystems in Africa by contributions from an equitably distributed international authorship, while maintaining high academic standards. The alignment and scope of the ‘new’ PoA strongly focuses on geographical and landscape aspects (see [www.crcpress.com/browse/series/poa/](http://www.crcpress.com/browse/series/poa/) for recently published volumes 28-32).

Submitted contributions may have a length between 15-25 pp. (including all figures and graphs, black & white) according to the PoA layout rules (see ‘notes for contributors’) and they should not have been published yet in similar way and should preferably contain innovative study results. All manuscripts will pass through an international review process by the editorial board.

Please submit your complete contribution up to **September 1<sup>st</sup>, 2014** to the editor (Jürgen Runge, [j.runge@em.uni-frankfurt.de](mailto:j.runge@em.uni-frankfurt.de)) following the formal requirements mentioned within the attached ‘notes for contributors’. Contributions will be peer-reviewed and publication date of volume 33 is already planned for April/May 2015.
